**GUIDELINES ON THE UTILIZATION OF DOWNLOADED FUNDS  
FOR THE PROVISION OF LEARNING RESOURCES  
AND/OR DEVICES FOR SY 2022-2023**

To: Schools Division Superintendents

1. With reference to DepEd Memorandum DM-OUCI-2022-075 from the Office of the Undersecretaries for Finance and Curriculum and Instruction, this Office through the Curriculum and Learning Management Division (CLMD) – Learning Resource Management Section (LRMS) provides information on the utilization of the downloaded funds for the provision of learning resources and/or devices for SY 2022-2023.
2. Allocation for each Division is specified in the attached Sub-Allotment Release Order (Sub-ARO).
3. The following are the eligible/allowable expenses of the downloaded amount, to wit:
  - Development and production of Self-Learning Modules, Learning Activity Sheets, Manuals and Worksheets
  - Devices such as, but not limited to tablets, smartphones, speakers, two-way radios, or other similar devices in support of the adopted learning delivery modality.
  - Other expenses to cover supplies for the development and delivery of video and radio script lessons, conversion of materials into an accessible format
  - Development of interactive materials
  - Expenses related to the implementation of the different learning modalities
4. Further, SDOs are advised to prioritize the procurement of Tablets to minimize reliance on printed LRs and the augmentation on the use of digitized LRs. However, If the SDOs do not anymore need to procure tablets, they may utilize the said funds to other eligible/allowable expenses based on their LR needs for the implementation of the Basic Education-Learning Continuity Plan (BE-LCP).
