**DIVISION MONITORING ON THE SCHOOL-BASED FEEDING PROGRAM
AND OTHER RELATED COMPLIMENTARY PROGRAMS**

To: Schools Division Superintendents

1. The Department of Education through the Education Support Services Division – School Health Section continues the implementation of the School Based Feeding Program (SBFP) nationwide in accordance with the General Appropriations Act (GAA) FY 2025 and in compliance with the RA 11037 also known as the “*Masustanyang Pagkain Para sa Batang Pilipino Act*”, which constitutes the primary statutory basis for the School-Based Feeding Program. It aims to implement programs that sustain and improve the health of school children.

2. As per DepEd Order No. 31, s. 2021, *Operational Guidelines on the Implementation of the School-Based Feeding Program*, the regional monitoring team shall monitor monthly (thru face to face or other means) the activities of the SDOs such as engagement with partners, request for funds, submission of required documents from the schools/SDOs, timely release of funds, progress of implementation, liquidation of funds and ensure that the program is implemented on time and in accordance with the set standards. Oplan Kalusugan sa DepEd (OKD) programs and other related complimentary programs will also be monitored.

3. All monitors are expected to provide appropriate correction of practices that are not in accordance with the guidelines and to recommend interventions to address problems or issues.
