LEADERS TO NEAP R-XII BATCH 2**

1. This is a reiteration of Regional Memorandum HRDD No. 1, s. 2021 re ***Call for Submission of Professional Development Program and Course Proposals for Public School Teachers and School Leaders to the National Educators Academy of the Philippines (Batch 2)***.
2. Relative to this, the National Educators Academy of the Philippines Central Office (NEAP CO) extends the deadline of submission of professional development program and course proposals until **May 31, 2021**.
3. All DepEd units in DepEd SOCCSKSARGEN are therefore encouraged to submit their proposals for NEAP Recognition to the Human Resource Development Division (HRDD) on or before **May 21, 2021** to give time for the Regional Evaluation Committee to scrutinize the proposals before endorsing them to NEAP CO.
4. NEAP CO shall be issuing Implementing Guidelines on the Allocation and Utilization of the Human Resource Development (HRD) Fund for Personnel in Schools and Learning Centers which may include as per advance information, subject to approval of the Secretary that all DepEd learning and development activities that shall utilize MOOE and HRD Funds must be NEAP Recognized.
5. Non-DepEd Learning Service Providers (LSPs) with authorization numbers shall submit their proposals directly to NEAP CO through [askneap@deped.gov.ph](mailto:askneap@deped.gov.ph).
