**INVITATION TO THE FINANCIAL EDUCATION PROGRAM OF THE CIVIL

This has reference to the invitation of the Civil Service Commission (CSC), through the Civil Service Institute (CSI), in partnership with the Bangko Sentral ng Pilipinas (BSP) and the BDO Foundation, for its online learning program titled "Financial Education: Take Charge of Your Financial Future!".
