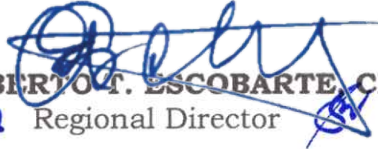
4. Enclosed is the Indicative Schedule of Activities for reference.
