1. Pursuant to Republic Act No. 11223, otherwise known as the Universal Health Care (UHC) Act, all Filipino citizens are automatically enrolled in the National Health Insurance Program (PhilHealth) to ensure equitable access to quality health services. In support of the Handog ng Pangulo 2026 initiative and the implementation of the UHC Act, the PhilHealth Regional Office XII will conduct the **“YAKAP Para sa Eskwela”** program on **September 14, 2026**, simultaneously in selected schools across the region.

2. In line with this, the Department of Education Regional Office XII requests all Schools Division Offices to nominate **one school** in their respective divisions as the venue for the activity. School Heads of the selected schools are likewise requested to facilitate the participation of learners' parents/guardians, teaching and non-teaching personnel, and other identified beneficiaries.

3. The following are the proposed activities:
- PhilHealth membership registration and updating of member information
 - YAKAP Empanelment and FPE particularly for unassigned members and beneficiaries
 - Orientation on YAKAP Program and its primary care benefits;
 - Assistance in accessing and understanding available PhilHealth benefits and services
 - Information dissemination on preventive, promotive, and primary health care
 - PSA Co-location for PhilSys Registration
 - DOH Co-location for vaccination (subject to availability).

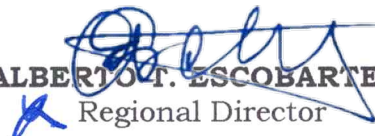
